



RosiesHouse.org Terms of Use

Rosie's House: A Music Academy for Children, Inc. ("Rosie's House", or "we", "us", or "our", as applicable) provides the website www.rosieshouse.org (the "Website") and various charity-based resources, services, content, media, and information (the "Services"). In this "Terms of Use" document, your "use of the Website" or similar language means your accessing, downloading, visiting, or browsing the Website, sending or receiving email or other electronic communications to or from us, and other similar events or services offered in connection with the rosieshouse.org domain.

Before using the Website, you must review and agree to the Terms of Use. If you do not accept these Terms of Use, you may not use the Website.

1. Amendment to Terms of Use. We reserve the right to amend or replace these Terms of Use from time to time in our sole discretion, and will post and maintain the most recent version of these Terms of Use on the Website.
